

## Arizona Lottery – Arizona Adventure (effective 08/02/2022)

This promotion and/or any parts thereof, including the award of any prizes, is void where prohibited by laws outside the State of Arizona.

### Game Period

The Arizona Lottery (the "Lottery") is conducting an online Promotion (the "Promotion"). The Promotion period begins on or about August 2, 2022, and continues until 11:59:59 p.m. Arizona Time on December 7, 2022.

### How to Enter the Promotion

1. A player may enter the Promotion by: 1) visiting the Arizona Adventure promotional website AZADventure.com; 2) going to [arizonalottery.com](http://arizonalottery.com) and clicking on the Players Club link; 3) going directly to the Players Club website at [azplayersclub.com](http://azplayersclub.com) (the "Website"); or 4) using the Arizona Lottery Players Club mobile app (the "Mobile App").
2. A player must complete the required registration information and confirm that the player is: 1) is twenty-one (21) years of age or older; 2) has voluntarily waived confidentiality rights under A.R.S. § 5-573(D); and 3) has read the Official Rules of the Promotion.
3. To enter the Promotion, a player must 1) Check-in using a mobile device while visiting any of the geo-locations designated on AZAdventure.com or 2) Have purchased at least one (1) designated Lottery gameticket (each "Game Ticket") during the Promotion period, from an authorized retailer of the Arizona Lottery within the boundaries of the state of Arizona. Eligible games for the Promotion are as follows:

4. Eligible games are subject to change. Any changes will be posted on the Players Club Website and Mobile App as they become available. Sale dates and draw dates are subject to change.
5. A player must submit the required entry information from an eligible winning and non-winning Game Ticket.
6. It is the responsibility of a player to enter any winning tickets **prior** to claiming prizes. Upon claiming a prize, the retailer may keep the validated winning ticket and the required entry information may no longer be available to the player. A Game Ticket entered into the Players Club Website or Mobile App must still be brought to an authorized Arizona Lottery retail location to claim any original game prizes.
7. A player is not required to retain a Game Ticket once it has been successfully entered via the Players Club Website or Mobile App; the Website will show a successful entry. A player will see Promotion entry in their account history at the same time the ticket is entered but points may take up to 48 hours to be reflected in their account history.
8. Players may enter each drawing multiple times but must have a separate Game Ticket for each entry. A Game Ticket may be entered only one (1) time.
9. Players will receive one (1) entry for each eligible Game Ticket entered. Arizona Adventure Instant Scratch game tickets will receive five (5) entries.
10. Players can earn (10) entries by visiting any of the geo-locations designated on AZAdventure.com and “checking in” via mobile phone while at any of the locations. Entries are only redeemable one time at each location. Entries for geo-location check-ins will be available August 2, 2022 – November 30<sup>th</sup>, 2022. Instructions for checking in available at AZAdventure.com.
11. An entry received during a specified entry period is eligible for the corresponding drawing. Entries cannot be submitted after the entry deadline for the final drawing. Entries for this Promotion shall be automatically entered into the Grand Prize Drawing for this Promotion.
12. During the Promotion period, the Lottery may add special features to the Promotion allowing a player to receive additional entries for Arizona Adventure geo-location check-ins, or for Game Tickets entered into the Promotion. Such special features may include, but are not limited to, double entries on a specific day, specific Game Ticket combinations for “super entries,” or any other special requirements designed to increase sales or awareness of the Games. Any special features will be noted on the Arizona Adventure microsite, the Lottery website and Mobile app.
13. Players may enter up to a total of fifty (50) eligible Game Tickets per day into the Players Club Website and Mobile App. For purposes of this Promotion, a day is defined as that period of time which starts at 12:00:00 a.m. Arizona Time and ends at 11:59:59 p.m. Arizona Time.
14. Only entries received during the specified entry period are eligible for the drawing.

15. Game ticket entries may only be submitted using the Players Club Website or Mobile App. Mail-in entries, hand-delivered entries, or entries dropped off at the Lottery offices will not be accepted.
16. If a dispute arises over the eligible entrant, the named Player of the email account associated with the entry registration will be the official entrant.

## Drawings

1. Five (5) drawings will be held. The drawing date and entry periods are as follows:

All times referenced in the chart above are Arizona Time.

2. Ten (10) Prizewinners and thirty (30) alternates will be selected for Draw 1 through Draw 4. The Grand Prize Draw will select one (1) winner and three (3) alternates. If a selected winning entry is determined to be invalid, and thus disqualified, the next available alternate will become eligible to assume the prize. In the event the Prizewinner and initial alternates are disqualified, additional alternates will be selected from the same pool of entrants used for the drawing.
3. The Prizewinners name and town of residence will be posted on the Players Club Website and MobileApp following the validation of the Prizewinner. Prizewinners shall be notified via email and/or phone by the Lottery or its designee within seven (7) calendar days after the drawing. The Prizewinner list is subject to change based on verification of the Prizewinners by the Lottery.
4. Prizewinners shall be randomly selected from all valid Players Club Website and Mobile App entries received for each drawing.
5. Drawings will be conducted by Pollard Banknote Limited on behalf of the Lottery at their offices at 1499 Buffalo Place, Winnipeg, Manitoba, Canada. Drawing location may change at the discretion of the Lottery. Any changes will be noted on the Arizona Adventure microsite, the Lottery website and the Mobile app as they become available.
6. Drawing dates and the number of drawings are subject to change at the discretion of the Arizona Lottery. Any changes will be noted on the Arizona Adventure microsite, the Lottery website and the Mobile app as they become available.

**Prizes**

1. A player is eligible to win only one (1) prize per drawing.
2. The prizes and corresponding prize levels for the drawings are as follows:

3. Prizes are not transferable.
4. The odds of winning vary, based on the total number of entries received for a drawing and the total number of entries a player submits.
5. Players are responsible for ensuring that their email address is secure to accept payment. The Arizona Lottery is not responsible for compromised or insecure email accounts and no refund will be issued in the event that winning payment to your account is compromised.

**Entry Eligibility Requirements**

1. All drawing entries are subject to validation by the Lottery or its designee and may be disqualified if eligibility requirements are not met.
2. A Player must be twenty-one (21) years of age or older to purchase a Game Ticket and enter the Promotion.
3. Players, Game Tickets, transactions, and Prizewinners are subject to all Lottery Official Rules, state laws, orders of the Lottery Commission, the Terms of Use and the Privacy Policy on the Players Club Website and the Lottery drawing procedures.

**Disqualification**

1. Tickets determined to be in a stolen/missing inventory status or not part of any inventory status that is invalid, sold, activated, or promotional will be disqualified.
2. The Players Club Website and Mobile App are the only methods of ticket entry into this Promotion. Entries sent via any other method, U.S. mail/courier, drop-off, etc., will not be opened and/or reviewed and will be disqualified.
3. A.R.S. § 5-573 requires winners of a prize valued at \$600 or more to be checked to determine if that winner owes money to certain State of Arizona entities. If any winner owes money to the State of Arizona, that winner will be disqualified from winning.

4. A "Related Person" is ineligible to receive prizes under A.R.S. § 5-567. A Related Person is defined as an officer or employee of the Lottery; an officer or employee of any person contracting with the Lottery to supply gaming equipment or lottery tickets, advertising or consulting services or to draw or otherwise select winning tickets or shares if the officer or employee is involved in the direct provision of goods and services to the Lottery or has access to information made confidential by the Lottery; and any spouse, child, sibling, cohabitant, or parent residing as a member of the same household in the principal place of residence of a person described above.
5. The Lottery and/or its administrators, at their sole discretion, may disqualify a player, Prizewinner, or designee from participating in any aspect of the Promotion if they deem or suspect that such person has engaged in or has attempted to engage in any of the following: (a) acting in violation of the law, these Official Rules, or the Terms of Use or Privacy Policy; (b) damaging, tampering with or corrupting the operation of the Arizona Adventure microsite, the Players Club Website or Mobile App; (c) acting with intent to annoy, harass, or abuse any other person; (d) using any automated bot, macro, script, or other robotic, mechanical, programmed or automated devices to submit data or spam to the Players Club Website or Mobile App; (e) making repeated attempts to submit invalid multiple entries; (f) participating in any unsportsmanlike, inappropriate, uncooperative, disruptive, fraudulent, or potentially fraudulent behavior or activity; or (g) participating in any activity deemed to be generally inconsistent with the intended operation of the Promotion. CAUTION: ANY ATTEMPT BY A PERSON TO DELIBERATELY DAMAGE OR CORRUPT ANY OF THE LOTTERY'S WEBSITES OR UNDERMINE THE LEGITIMATE OPERATION OF THE PROMOTION IS A VIOLATION OF CRIMINAL AND CIVIL LAWS. SHOULD SUCH AN ATTEMPT BE MADE, THE LOTTERY AND ITS ADMINISTRATORS RESERVE THE RIGHT TO PROSECUTE AND SEEK DAMAGES FROM ANY SUCH INDIVIDUAL TO THE FULLEST EXTENT OF THE LAW.

### **Use of Personal Information**

1. The collection, use, storage, and destruction of personal information submitted by a player for participation in the drawings will be managed in accordance with the Privacy Policy and the Terms of Use of the Players Club Website.
2. A player is required to be twenty-one (21) years of age or older to provide information that will be collected on the Players Club Website.
3. By submitting a drawing entry on the Players Club Website or via the Mobile App, a player gives the Lottery permission to announce and publish the player's name, city and state for marketing/promotional purposes if the player wins a prize. Because a second chance drawing is exclusively used as a promotional event, a person who participates in a second chance drawing is deemed to have voluntarily waived the right under A.R.S. § 5-573(D) to keep his or her name confidential for ninety (90) days after winning a prize. A player who does not want to consent to immediate release of his or her name as a winner should not participate in this promotion, will be ineligible to receive a prize in a second chance drawing, and will be disqualified if chosen as a winner, resulting in selection of an alternate winner.

### **Claiming Requirements**

1. Prizewinners must provide their legal name and address. For prizes of \$600 or more, Prizewinners must complete a Winner Claim Form, provide their taxpayer ID (typically

their social security number), provide a form of government-issued photo identification, and pass all validation checks prior to claiming their prize. The Lottery will report such wins to the applicable tax authorities. Each Prizewinner is responsible for his or her state, federal, and/or local taxes.

2. Prizewinners must claim their prize within seven (7) calendar days from the prize winner notification date by the Lottery. If all reasonable efforts to locate a Prizewinner fail within the seven (7) calendar-day period, the Lottery may select a replacement winner as previously described.
3. Disqualification, forfeiture, and the selection of alternate potential winners may result from any of the following: (a) the potential winner's failure to respond to any notification within the specified response period; (b) the return of an email notification as undeliverable after three (3) attempts; (c) the return of any other notice as undeliverable; (d) the potential winner's failure to provide satisfactory proof of age, identity, and residency; (e) the potential winner's failure to execute and return the required documents (including, without limitation, the Winner Claim Form) within the specified return period; (f) the potential winner's failure to be available to receive the prize; (g) the potential winner's failure to validly claim the prize by the date specified in the prize award notification; or (h) any other non-compliance with the law, these Official Rules, the Terms of Use, or the Privacy Policy. In the event of a forfeiture of the prize, the Lottery may, in its sole discretion, award or not award the forfeited prize to an alternate winner.

#### **Miscellaneous**

1. Approximately one hundred eighty (180) days after the completion of the Promotion, all non-winning, non-selected and/or ineligible entries shall be deleted.
2. The Lottery reserves the right, in its sole discretion, to modify these Official Rules without materially affecting the terms and conditions of the Promotion. The Lottery reserves the right to modify, cancel, postpone, delay, suspend, and/or terminate this Promotion, in whole or in part, in the event that the Promotion is not capable of running as planned or as intended by these Official Rules, by reason of any technical or other disabling causes, or other causes that impair, corrupt, or interrupt the administration, fairness, security, integrity, or proper play of the Promotion, including, without limitation, hurricane, fire, flood, epidemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, war, terrorist threat, or activity or insurrection. In such event, the Lottery may, in its sole discretion: (a) postpone and/or reschedule and/or modify the Promotion, or (b) cancel the Promotion in its entirety. In the event of cancellation, the Lottery shall award the prizes through a process deemed fair and equitable by the Lottery, in its sole discretion, and the Lottery and its administrators shall have no further liability to any participant in connection with the Promotion. In no event will the Lottery be obligated to award more prizes than the number of prizes stated in these Official Rules.
3. Whether caused by a player, equipment, or programming associated with or utilized in this Promotion, or by any technical or human error that may occur in the processing of entries, the Lottery, Pollard Banknote Limited are not responsible for inaccurate entry information or errors that may occur in the processing of the Promotion that may be the result of: (a) error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries; or (b) lost, misdirected, late, incomplete, corrupted, illegible, or unintelligible entries. Corrupted, illegible,

unintelligible, or incomplete entries are void.

4. The Lottery reserves the right to substitute prizes with similar merchandise of equal or greater value. No prize substitution, cash equivalent, or transfer of prize by a winner in violation of these Official Rules is permitted. By accepting a prize, a player agrees to release the Lottery and Pollard Banknote Limited from, and shall hold them harmless against, any liability, loss, claims, injury, or damage to property or to person, including death, due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use or misuse of the prizes or participation in this Promotion, even if caused or contributed to by the negligence of the Lottery and Pollard Banknote Limited.
5. This Promotion is governed by laws and regulations of the State of Arizona, and all players hereby submit to the exclusive jurisdiction and venue of the State of Arizona for resolution of all claims and disputes through administrative hearing, and any right to a trial by jury is hereby waived. Any and all disputes, claims, and causes of action arising out of or connected with this Promotion or any prize awarded are governed by Arizona Administrative Code ("A.A.C.") § R19-3-1008. The decision of the Lottery is final. Any decision by the Lottery Director is a final, appealable agency action to the Office of Administrative Hearings under the procedures of A.A.C. § R2-19-101 through § R2-19-122. Exhaustion of administrative remedies applies.
6. If any provision or provisions of these Official Rules, the Terms of Use, or the Privacy Policy is, or will be, held to be invalid, illegal, unenforceable, or in conflict with the law of any jurisdiction, the validity, legality, and enforceability of the remaining provisions will not in any way be affected or impaired thereby. The Lottery's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
7. Players or interested parties must use the Feedback form for any questions or comments they may have about this Promotion.
8. This Promotion is not sponsored or endorsed by, or affiliated in any way with Apple, or any other third party application provider or affiliate.

## Arizona Adventure 2022 Promotion FAQs

### Questions about entries and tickets

**Q: Which tickets can be entered into this Promotion?**

A: Eligible games are listed on the Players Club promotion page. Winning and non-winning tickets from the designated games can be entered into the promotion.

**Q: How long does the Promotion run?**

A: The promotion period begins on August 2, 2022, and continues until November 30, 2022. Any changes to the promotion period will be posted on the Players Club Website the Players Club Mobile App as well as AZadventure.com.

**Q: Where can I find my entry history?**

A: All of your entry history will be listed in your Players Club Account History. You can access your Players Club Account History at AZPlayersClub.com

**Q: Can I scan my tickets into the promotion using the Players Club app?**

A: Yes, all eligible tickets entered through AZAdventure.com, AZPlayersClub.com, or on the Players Club Mobile app will count toward the promotion.

**Q: How many entries do I get for visiting and checking-in at one of the geo-locations identified at azadventure.com?**

A: Players will receive 10 entries for checking-in at each geo-location site. It is the Player's responsibility to visit and check in during each location's open hours of operation.

**Q: Can I check in to the same Adventure multiple times to receive more entries?**

A: No, only one 'Check-In' is allowed per Adventure location during the promotion.

**Q: Why do I have to give access to my location?**

A: You must give AZAdventure.com access to your location so the website can confirm you are at the check-in point.

**Q: How do I turn on my location?**

A: You can find your location settings in your device settings. Go to your device settings and grant location access for AZPlayersClub.com and AZAdventure.com

**Q: Are there fees to complete an Adventure?**

A: All Adventure locations are subject to Arizona State Parks and Trails [Fees](#) and Hours of Operation.

**Q: I am at the check-in location, but the website is telling me that I am not within the radius to check-in.**

A: Please make sure you are within a 1-mile radius of the Park Entrance or Welcome Center.

**Q: My cellular coverage is bad and I can't check-in.**

A: Mobile internet services are not provided or controlled by the Arizona Lottery therefore the Lottery cannot guarantee connectivity at any specific location. Furthermore, the Lottery does not warrant that such services will be uninterrupted, error-free, or



completely secure. As such, the Arizona Lottery disclaims any and all liability arising out of, resulting from or related to, the Internet infrastructure or your ability or inability to connect to the Internet.

**Q: How many entries do I get for each ticket I enter?**

A: Players will receive one (1) entry for eligible \$5 Scratchers and for eligible \$5 Fast Play tickets, and five (5) entries for \$5 Arizona Adventure Scratchers. Players are able to enter up to 50 tickets per day. Tickets can be entered at AZadventure.com, via the Players Club Website or Players Club Mobile App.

**Questions about winners**

**Q: How are the winners selected?**

A: Winners will be randomly selected from all entries received for each drawing.

**Q: What are the prizes for the Arizona Adventure 2022 Promotion?**

A: Prizes are listed on the promotion page as well as on AZadventure.com.

**Q: Can I win a prize more than one time?**

A: Yes. A player may win more than one time during the Promotion, but only one prize per drawing.
